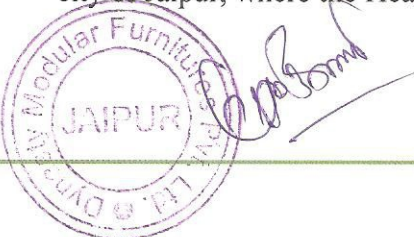
Your employment in this company shall be governed by the rules and regulations of our company as applicable to our employees from time to time.
