All operations regarding Montenevoso have to be controlled and approved by Nicoletta Cursi:

- Choice of suppliers, order process to suppliers, approval of quality of components purchased, efficiency of suppliers.
- Factory has to follow some strict rules to save final quality of components (from receiving goods to delivery and assembling) – there are 3 months of time to update the behaviour from now. In separate documents details of quality system control will be given.
- Delivery on site and installation (and installation team) to be approved and trained for each installation by Nicoletta Cursi to avoid mistakes.

Damaged components (scratches, wrong dimensions, lacquering defects, wrong holing) will be rejected from Montenevoso and redone by Dynasty.

All advertising instruments as banners, catalogues, website, invitation and others done in the name and brand of Montenevoso has to be done or approved by Nicoletta Cursi.

In case of delay of delivery to final customers that cause penalties to Montenevoso the penalties will be paid by Dynasty if the delay is due to Dynasty.

All contacts taken in the name of Montenevoso has to be followed by Montenevoso even if there are changes in characteristics and level of price. Montenevoso can manage also downgrading but it is not tolerable to enter with a client in the name of Montenevoso and continuing in the name of Dynasty. In case Montenevoso doesn't want to continue will pass the work to Dynasty but only in this case.

All offers done by Montenevoso must be billed in the name of Montenevoso.

Dynasty cannot become a competitor of Montenevoso using the project and the name of Montenevoso.

Any religious symbols or items related to spirituality or superstition have not to enter into the process of work of Montenevoso or affect in anyway the work and the image of the brand (except for the respect of holidays).

The rules of maintenance and cleaning of the showrooms given by Nicoletta Cursi have to be strictly observed (vacuum cleaner, proper instruments) as these ambiances have to be

always clean and in order as per the client expectation in an Italian shop.

Any finished furniture that is not done in the name and project of Montenevoso (approved by Nicoletta Cursi) have to be placed in the Montenevoso showrooms.

No one can deny the access to the working area (offices and factory) to Nicoletta Cursi
No one can remove working instruments and object and personal effects of Nicoletta Cursi from the offices where she is usually working or tamper with computer components in order to prevent work.

More generally, Nicoletta Cursi will not tolerate otherwise inappropriate and harmful behaviour to the profession. As it is not possible to list all the possibilities more generally, she is keen to point out that she expects to be treated according to a natural common sense of justice, legality, correctness, civilization, human and professional respect that concerns every member of a company that respect.

In case of problems regarding these points Nicoletta Cursi will leave the company immediately allowing Dynasty to work with the same project but retaining the right to be the owner of the name and full company MONTENEVOSO and reserves the right to appeal to the court in the event of damage resulting from harmful behaviour.

If there have been commercial and administrative misconduct from the starting of the activity till date, it is expected that they will be corrected in some way before the end of the financial year.
