_____ under my own responsibility and fully aware of the consequences, including criminal liability for false, misleading, and/or inaccurate/incomplete statements, and in any case untrue declarations, pursuant to and for the purposes of DPR 445/2000, regarding the activity taking place in BASIGLIO (MI) – Sporting Milano3, from 28/11/2025 to 30/11/2025, declare:

1. That I have the full authority and capacity to sign this declaration, and that I understand the nature and type of the activity.
2. That I am in suitable physical and psychological condition to participate in the activity and do not suffer from any condition that may compromise my own safety or that of other participants.
3. That I have not used drugs in the 48 hours prior to the activity and will not use them during the duration of the activity. That I am not under the influence of medications and have not excessively consumed alcoholic beverages and/or food. I understand that, otherwise, the organizer and/or instructor may exclude me from participating and that I will not be entitled to any refund and/or compensation.
4. That I participate in the activity and carry out all related actions voluntarily and optionally.
5. That I am aware of predictable risks and conscious of unpredictable risks associated with the activity.
6. That I am aware of the “Official Pickleball Rulebook – 2025 Edition” and have fully understood and accepted everything contained therein, as well as any other rules communicated in writing or verbally.
7. That I will behave in a non-violent manner and in compliance with legality, public order, and decency toward the organizer, their legal representative, employees and/or collaborators, instructors, other participants, and any third parties I may come into contact with, as well as the owners of the premises and equipment, and that I will use the provided facilities and equipment accordingly.
8. That I personally assume full civil and criminal liability toward the individuals and objects mentioned in point 7 for any consequences arising from participation in the activity, including but not limited to accidents, injuries, illness, or damages.
9. That I am aware that the organizer provides no insurance coverage unless otherwise communicated in writing, and that I am responsible for any medical or insurance expenses.
10. That I am aware of the possible need for movement inside or outside the facility, whether organized by the organizer or independently, and that I assume all responsibilities and consequences for any damages that occur during such movements, to myself or any subjects mentioned in point 7.
11. That I release and hold harmless the organizer, their legal representative, employees and/or collaborators, from all civil and criminal liability, including strict liability, arising from participation in the activity, accidents and/or injuries sustained and/or caused to myself or others, as well as illness (including death or temporary or permanent disability) connected to the activity, including accidents caused by other participants.
12. That I hold harmless the organizer and the aforementioned parties from any claim made by third parties, also covering any potential legal expenses.
13. That I waive any and all present or future claims for compensation and/or reimbursement toward the organizer, their legal representative, employees and/or collaborators, releasing them from any liability related to injuries, damages to myself, third parties, or third-party property, damage to equipment, or loss/theft of personal belongings, except where otherwise required by law.
14. That I release the organizer, their legal representative, employees, and collaborators from any liability for losses, thefts, damages, or expenses.
15. That I am aware that my personal data (including health-related data) is processed in accordance with European Regulation (EU) 2016/679 for purposes connected to the activity and/or required by law.
16. That I am aware that the activity may be subject to photographic, journalistic, radio-TV, or video recordings and therefore authorize their production, including those featuring my person/image, for use in promoting institutional activities. This authorization is granted freely, without conditions or reservations, completely free of charge, and without time limitations.
