Personal Data Protection and Privacy Policy

Disclosure - Article 13 of the Personal Data Protection Code (Legislative Decree 196/03)

Why read this disclosure?

Dr. Veronesi Vanni will use a series of information about you, and you have the right to be informed of what this information is, for what purposes and how it will be used, to whom it may be disclosed, etc. Above all, you will be able to choose whether or not to authorize Dr. Veronesi Vanni, through your consent, after being informed of the mandatory or optional nature of consent and the consequences of refusal.

What information about you will Dr. Veronesi Vanni collect and use?

Both general information (personal details, postal and telephone numbers, images, etc.) and information relating to your health, the latter defined by law as "sensitive" data. * This information may be provided by you or acquired through medical records during examinations or visits. Specifically, "sensitive" data may only be processed with your consent or that of authorized persons**, documented in writing. Consent will be considered valid for any further access until revoked or rectified.

What purposes will be pursued with the information acquired?

Subject to your separate consent for each indicated purpose, the information will be used:

- for diagnosis and treatment purposes (including follow-up checks) and for related institutional activities, such as administrative and statistical purposes, and for improving the quality and safety of clinical and healthcare pathways.
- for scientific research purposes in the medical and biomedical field. In particular, to determine any correlations between information on your health status and the results of treatments you have undergone or will undergo. The results could contribute to the advancement of research, including in your personal case, and may be disclosed only if your anonymity is guaranteed.
- Furthermore, personal information, postal, telephone, and email addresses may be used to send further communications from Dr. Veronesi Vanni and/or the administrative staff of Second Opinion.

What happens if you deny your consent for the indicated purposes?

- For diagnosis and treatment purposes, consent to the use of personal and sensitive data is essential. Failure to provide consent will make it impossible to provide any service, except, of course, in situations of urgency, as required by law, for which, even without consent, data necessary for the performance of essential healthcare activities will be processed.

How will the information be processed?

Using paper and electronic means, in compliance with current data protection regulations and adopting appropriate security measures. The data retention period will depend on the type of document containing it. To find out the retention periods for various documents, please contact the Data Protection Officer listed below.

To whom may information about your health be disclosed?

This information will not be disclosed to third parties unless necessary or required by applicable law. Information about your health may be disclosed to family members and acquaintances only with your explicit authorization.

Who is the data controller?

Veronesi Vanni, "Degli Infermi" Hospital, Viale Stradone 9, Faenza (RA), Romagna Local Health Authority.

Summary of main consents required for the processing of personal and sensitive data.

You will be asked to provide the following consents in writing, which will be considered valid for any further access until revoked or rectified:

- to the processing of personal and sensitive data for diagnostic and treatment purposes and for related institutional activities such as administration, statistics, and improving the quality and safety of clinical and care pathways;
- to the processing of personal and sensitive data for scientific research purposes in the medical and biomedical fields. The results may contribute to research progress and will be disclosed only if anonymity is guaranteed.

Second Opinion Report Delivery

The Second Opinion report can only be delivered to you and will be sent to the email address you provide.

* Sensitive data means "personal data revealing racial or ethnic origin, religious, philosophical, or other beliefs, political opinions, membership of parties, trade unions, associations, or organizations of a religious, philosophical, political, or trade union nature, as well as data revealing health or sex life" (letter d, paragraph 1, art. 4 of the Personal Data Protection Code).

** If the data subject is unable to give consent due to physical incapacity, legal incapacity, or mental incapacity, consent must be given by the person legally exercising parental authority, a next of kin, a family member, a cohabitant, or, in their absence, the person responsible for the facility where the data subject resides (letter b, paragraph 4, art. 26 and paragraph 2, art. 82 of the Personal Data Protection Code).
