A) photography, card format, for document use; **B)** legible and clear integral photocopy of your valid identification document (passport - identity card); **C)** detailed and signed curriculum vitae; **D)** copies of any supporting documents in relation to the position of the application form; **E)** certificate of pending charges and of the certificate of the general register for use in rehabilitation.

The application must be submitted under one's own responsibility in one of the following ways:

1. by postal service with registered mail to the address indicated on the application or on the website in the contact section;
 2. personally by the aspiring candidate at the nearest branch of the C.I.D.G., by appointment (Italy and Abroad);
- by e-mail addressed to the Secretariat, attaching the complete documentation, which can be supplemented, if required, with points 1. and 2.

In the case of admission to the CIDG - International Council for Diplomacy and Justice, the Senator, the Deputy and the Councilor will be held promptly to pay the membership fee for the current year as established by the Board of Directors while, for the following years the deadline will be that of January 31st.
