## DOCUMENTS TO PREPARE

The relevant documents (income and expenses for 2022) to file your 730 form include (but are not limited to):

- Copy of last paycheck for 2023
- Copy of tax ID card: personal, spouse and/or dependents (and relevant ID documents).
- Copy of tax return (Redditi or 730 Form) from previous year.
- Any payment authorisations for ADVANCES
- Copy of IMU declaration and/or notice
- Single certification 2023
- Certification of indemnities or amounts paid by institutions (INPS, INAIL, Special Construction Workers' Fund, etc.) not reported to your withholding agent for adjustment
- Deed of sale or acquisition of land and or other properties made in 2022 (or early 2023)
- Proof (certifications) of other income (rents, dividends, collaborations, etc.)
- DEDUCTIBLE and DETRACTABLE EXPENSES documented by invoices, receipts or tickets for performance or for the purchase of: medical expenses including those for family members (financially dependent) (visits and medical care in general, including dental / homeopathic, surgery, transplants and hospitalizations, glasses and lenses with prescription, hearing aids, health equipment, health attendance, vehicles for the handicapped or disabled etc.) interest paid on home loans (with presentation of deed of sale and mortgage contract); Health, Life and calamitous events insurance; donations to non-profit organizations; school fees; funeral expenses; veterinary expenses; social security contributions (voluntary, mandatory, etc.); domestic staff (housekeeper) expenses, adoptions of foreign children, donations from various agencies / institutions / associations; home renovations, purchases of furniture for renovated properties and VAT on A- or B-category dwellings; payments to supplementary pension funds; rental leases (L.431/98 due to job transfers, student away at school, etc.); expenses incurred for caregivers in case of disability; energy saving investments annual registrations or subscriptions to sports clubs, gyms, swimming pools (for children between 5 and 18 years); childcare costs (up to 3 yrs of age), expenses for the purchase of season tickets for public transport
- Documentation certifying real estate and financial assets held abroad. Figures will be indicated within the RW and RM part of the Redditi Form to supplement the 730 Form.
