Interested in law and modern finance. Several of my commentaries are published by the best independent websites and institutional websites by the major public financial services authorities. I have been author of several articles on finance for alumni and professional practice on corporate governance issues. I have written on asset allocation, regulation of banks, hedge funds, mutual funds and intermediaries, the global competitiveness of financial markets, model risk, risk management and other financial innovations. The writings have appeared in many reviews of finance (e.g. Bologna University financial web review) and financial markets authority (CONSOB) consultation document on MiFID and on the regulation of intermediaries and advisers. A 2001 article suggested that “sophisticated” financial frameworks and practice will misunderstand macro to micro and micro to macro risk management because of cognitive biases (such as to ignore negative events), compensation structure, and other factors, and proposed possible responses (such as systematic fee only based asset manager or investment advisers for companies and individuals). It also showed how this phenomenon can introduce systemically hidden (morphable) ownership and undermine the soundness of individual corporations and the overall financial system.
