REGULATIONS

1) ORGANIZATION

Scuderia Brutia Historic Cars – Via G. Pezzullo, 2/A | 87100 | Cosenza – Federated Club No. 275

2) EVENT NAME

20th Grand Tour of Calabria – 21st Coppa della Sila Historical Reenactment

3) EVENT DATE

From Thursday, October 1st at 3:00 PM to Sunday, October 4th at approximately 3:00 PM.

4) PARTICIPANTS

Fifty (50) cars in possession of an ASI or FIVA Certificate of Identity, built before December 31, 1975, are admitted to the rally. Drivers must be ASI members with valid membership for 2026. At the organizer's discretion and in derogation of the above, foreign crews not affiliated with ASI and 10 sports cars (spider coupés) of particular collector's interest may be admitted. Participants must have a valid driver's license and third-party liability insurance. By signing these regulations, participants declare under their own responsibility that their third-party liability insurance policy covers claims even during participation in classic car events.

PLEASE NOTE: Registrations will be accepted based on the date of receipt and the proposed vehicle model, with the aim of diversifying the fleet as much as possible.

5) REGISTRATION DEADLINE

The final registration deadline is July 30, 2026, unless the number of fifty cars entered is reached before that date.

6) CATEGORIES

The cars will be divided into two categories:

- a) cars built before 1945;
- b) cars built between 1945 and 1975.

7) ROUTE

The route, which will total approximately 300 km, will be detailed in detail in the road book that will be given to all crews before the start. The Historical Reenactment of the Coppa della Sila will take place over a route of approximately 20 km.

8) SKILL TESTS

During the event, several skill and precision tests will be performed. Passing times will be measured using pressure gauges to the nearest hundredth of a second; a penalty is applied for

every 1/100th of a second of advance or delay, with a maximum of 300 penalties. Wheel stoppages result in 100 penalties. The use of traditional instruments (mechanical stopwatches) is permitted. To monitor the average speed of the event during transfers, timed passages will be recorded. Timed skill tests may be single or continuous.

9) TECHNICAL CHECKS

Technical checks will take place on Thursday, October 1st from 3:00 PM to 5:00 PM at Palazzo Arnone (National Gallery) - Via G. V. Gravina, 2 - Cosenza.

At the same time, plaques, identification stickers, and sponsor gifts will be distributed.

10) BRIEFING

The briefing will take place on Thursday, October 1st at 5:00 PM, also at Palazzo Arnone.

11) TROLLEY PARKING

The organizers will provide a trolley parking service.

12) ADVERTISING

Vehicles must not carry advertising plates. Only logos authorized by the organizers are permitted.

16) CANCELLATIONS

Any cancellations from the rally must be made in writing (email, fax, or mail).

Canceled participation will be subject to penalties as follows (hotel stays included):

- No penalty will be applied until June 30, 2026.
- 50% of the registration fee will be refunded until August 31, 2026.
- Cancellations after September 1, 2026 will not be refunded. This penalty also applies to non-attendance during the event or early departure.

17) RESPONSIBILITY

The Organizing Committee may reject, without providing any justification, any registration application deemed inappropriate. By signing the application, the undersigned binds himself/herself and his/her passengers to accept the regulations and any provisions that the organizers, the jury, and the guardians of law and order intend to adopt. The participant further

declares that he/she waives any right to resort to arbitration or courts for any reason for matters arising from the organization of the event. He/she also declares that he/she holds Scuderia Brutia and all entities or associations collaborating with or sponsoring the initiative, as well as the entities, owners, and managers of the roads traveled, as well as the organizing committee and all its employees, harmless from any liability or damage occurring before, during, or after the event to the participant, its passengers, and its employees. He/she assumes responsibility for any damage caused or produced to third parties or to the property of third parties by the participant, its passengers, or its employees. The competent court is the Court of Cosenza.
