Recognizing the urgent need for a global Medicine , Medical Science, Medical Education , Health systems shift to the Person-Centered Medicine Paradigm edited by Ambrosiana University (Italy) in 1999 in medical education, prevention and clinics according the ethical and epistemological principles of the World Health Charter, and the World Health Committee:

We establish this Society to serve as a platform for change health global system through research, medical education, health education, clinical practice in schools, primary care, hospital care, health education, prevention, and health communication.

Official languages of WSPCM are English and Italian.(honorary).

🌐 Bylaws of the World Society of Person-Centered Medicine (WSPCM)

Article 1 – Name and Legal Status

- **The organization shall be known as the World Society of Person-Centered Medicine (WSPCM).**
- **It is a non-profit, non-governmental, international association governed by applicable laws in its country of registration.**

Article 2 – Mission

- **To address global health and national health systems to the paradigm change of Health, Medicine, Medical science according ethical and epistemological principles of Person-Centered Medicine (PCM), stated in the [World Health Charter](#) by introducing Person-centered clinical method and Medical counselling teaching in Schools of Medicine according to the [Person-centered Medicine paradigm](#) written by prof.Giuseppe R.Brera and published in 1999..**

- To promote person-centered health as “ [Choice of the true possibilities for being the best human person](#)” in health education and clinics, stated by the World Health Charter, by changing the current WHO paradigm “ Psychophysical wellbeing”. (1946),.
- To promote physicians and nurses’ mission in prevention and clinical practice as the person’s realizing being inspired by Jesus Christ’s “ Good Samaritain” parable interpreting, constituting “the taking-care” of the suffering person and the establishment of hospitals for this purpose and the disease as an existential possibility to realize the human nature by being a real person , giving a meaning to the suffering by realizing in him-herself the objective truth, love and beauty.
- To promote the approval by the States of the World Health Charter

Article 3 – Objectives

- Change Medical Education addressing it to teach human nature teleonomic interactionism, Person-centered clinical method and medical counselling according to pioneers’ quality procedures of Milan School of Medicine of Ambrosiana University promoting the Person-Centered Medicine International Medical Education Program spreading into the world , the World Health Committee, and Person-Centered International Academy.
- Clinical and scientific research addressed to verifying the effects of medical education in Person-centered clinical method and Medical counselling in clinical practice and the impact of Person-centered Medicine in life quality and health systems
- Medical education in Person-Centered Medicine through PCMIA and the Person-centered medicine international program.
- Organize international congresses, symposia
- Collaborate with global health institutions and academic bodies.
- Advocate for ethical, inclusive, and culturally sensitive health care
- Promote the development of the open access scientific journal: “ Person-centered Medicine Journal.org editorial organ of WSPCM and World Health Committee
- Promote communication among international Medicine societies toward the adoption of the Person-centered medicine paradigm
- Cooperate with the World Federation and Society of Adolescentology to spread into the world the Person-centered health program (Kairos program) and with the ICYC(International Committee for the Youth Charter) for spreading the Universal Declaration of Youth Rights and Duties

Article 4 – Membership

- Open to individuals and institutions committed to PCM.
- Categories: Individual Members, Institutional Members, Honorary Members.
- Members have voting rights and may participate in governance.
- Individual membership is achieved by publishing a clinical report/scientific, and/or theoretical papers on the open access Journal “[Person-Centered Medicine Journal](#)” or [Medicine, Mind and Adolescence](#) the first international Journals on Person-Centered

Medicine.(the first) and Adolescentology (the second). .The membership is maintained by publishing every two years (at least) a paper on the WSPCM official journals.

- **Founder individuals and institutions are honorary members**

Article 5 – Governance

- **Governed by a General Assembly and an Executive Board.**
- **The Board includes: President, 2 Vice Presidents, Secretary,-Treasurer, and Presidents of National Societies and honorary members**
- **Elections held every 3 years; decisions by majority vote.**
- **Websites of WSPCM are www.personcenteredmedicine.it and www.healthparadigmchange.it.**
- **Official scientific press organ of WSPCM are the open access Journals: Person-centered medicine.org and Medicine,Mind Adolescence.it.**

Article 6 – Activities

- **Triennial World Congress on Person-Centered Medicine.**
- **Political contacts with WHO, European Commission, National health systems to promote the global transition of health systems to Person-centered health and Person-centered medicine**
- **Support for regional initiatives and observatories.**
- **Promotion of young investigators' activity on Person-Centered Medicine**

Article 7 – Funding

- **Funded through membership dues, grants, donations, and event revenues.**
- **Financial transparency and reporting are mandatory.**

Article 8 – Amendments

- **Statute amendments require a two-thirds majority vote of the General Assembly.**
 - **Proposals must be submitted to the President at least 60 days in advance.**
